MINUTES OF THE REGULAR CITY COUNCIL MEETING

Thursday, February 18, 2021

The meeting was called to order by Mayor Pro-Tem Jim Radke at 7:00 pm.

It was moved by Mike DeVoe and seconded by Chris Stewart to approve the consent agenda items which included the Agenda, Minutes from the January City Council Meeting, Claims for the City, Museum, Fire Department, and Mighty Wash, Financial Reports (Treasurer's Spreadsheet, Income and Expense, Balance Sheet), Minutes from the Special Meeting Jan 28, 2021, and Reconciliations (General Checking, Fire Dept, Petty Cash, Utility). All members voted in favor, motion carried.

It was moved by Mike DeVoe and seconded by Chris Stewart to approve Ordinance # 250 - Amending Chapter 92.02 - Water Rates. All members voted in favor, motion carried. First reading of the adopted Ordinance as below.

It was moved by Mike DeVoe and seconded by Bob Riddle to approve Resolution # 2021-07 Setting Public Hearing for the City of New Market FY22 Budget. All members voted in favor, motion carried.

It was moved by Bob Riddle and seconded by Mike DeVoe to approve Resolution # 2021-08 ICAP Member Proxy appointing Frank Sefrit as primary contact and Jim Radke as alternate contact. All members voted in favor, motion carried.
