MINUTES OF THE REGULAR CITY COUNCIL MEETING

Thursday, May 19, 2022

The meeting was called to order by Mayor Frank Sefrit at 7:07 pm.

Members present included Larry McAlpin, Chris Stewart, and Bob Riddle. Mike DeVoe and Jacob Cabbage were absent.

Mayor Frank Sefrit, City Superintendent Ben Fritz, and City Clerk Angie Tracy were also present.

It was moved by Chris Stewart and seconded by Bob Riddle to approve allowing Garden & Associates to secure interim financing for engineering and design of the Water Infrastructure Replacement Project. All members voted in favor, motion carried.

It was moved by Bob Riddle and seconded by Larry McAlpin to approve sending a letter about applying fines to nuisance agreements in which owners have not complied. All members voted in favor, motion carried.
