MINUTES OF THE REGULAR CITY COUNCIL MEETING

Thursday, June 20, 2024

The meeting was called to order by Mayor Frank Sefrit at 7:00 pm.

Members present included Larry McAlpin, Gene Chapman, Mike DeVoe, Mattea Fritz, and Justin Savage.

There were no members absent.

It was moved by Mike DeVoe and seconded by Mattea Fritz to approve the consent agenda items which included the Agenda, Minutes from the May City Council Meeting and May 30th Special Council Meeting, Claims for the City, Museum, Fire Department, and Mighty Wash, Financial Reports (Treasurer's Spreadsheet, Income and Expense, Balance Sheet), and Reconciliations (General Checking, Fire Dept, ARP, Petty Cash, Utility). It was moved by Justin Savage and seconded by Mattea Fritz to approve Resolution 2024-26 for Pay App #3 - Water Main Replacement Project. All members voted in favor, motion carried.

It was moved by Mattea Fritz and seconded by Larry McAlpin to approve Resolution 2024-27 Lucky Wife Wine Slushies Liquor Licenses. All members voted in favor, motion carried.

It was moved by Mike DeVoe and seconded by Larry McAlpin to approve Resolution 2024-28 Lawn Ordinance fees. All members voted in favor, motion carried.

It was moved by Mattea Fritz and seconded by Mike DeVoe to approve moving the road closure of the street dance from Main street to 4th Street from Adams to Main St.. All members voted in favor, motion carried.


Mike DeVoe made a motion to adjourn the meeting and it was seconded by Gene Chapman. All members voted in favor so the motion carried.
